How is the Substance Used?	Cement based coating used in application of colouring to concrete surfaces.	

Risks Involved with using the Substance:	Irritation to eyes. Can cause burns. Can cause health problems if ingested in large amounts.	
Health Aspects:	Potential chemical burns to eye/skin/hands/irritation. Potential skin irritation if exposed to long times or in large volumes. May cause nausea, vomiting, swelling, blisters. Potential to cause permanent lung damage if inhaled for long periods.

Necessary Controls:	Must be used in a well-ventilated area. Use protective goggles, dust mask, or full-face shield fitted with filter to AS. Heavy duty rubber gloves if skin is dry, cracked, split, or sensitive. Protective clothing to shield skin from contact. Safety or rubber boots.	
Approximate Quantity:	Up to 100 Bags (Depot) / Up to 50 Bags (Vehicles)	
Storage Requirements:	Store well in well-ventilated areas. Keep containers sealed at all times when not in use. Protect from physical damage. Keep away from ignition sources. Dispose of unused material safely.	
Required Safety Phrases:	In case of contact, do not induce vomiting, flush eyes with water continually, remove person/s from source. Keep head below knees to prevent aspiration. Immediately seek medical help. If swallowed, dilute with water. Contact poison control centre if medical help is unavailable. Transport patient to nearest medical facility ASAP if any contact with this chemical deemed to be dangerous is experienced.	
Monitoring Requirements:	Monitor workers for correct use during works. Use shifts to avoid inhalation of product over the allowed limits.
